WHO QUALIFIES for the discount?

High school students ages 13-18 only. Students under 13 do not qualify. Students enrolled in the following classes qualify for the Tamron EDU Program: Photography, Digital Photography, Graphic Design, Digital Art/Digital Design, Animation, Web Design/Interactive Design, Video Production, Film Studies, Media Production. Proof of enrollment in these classes must be supplied. A copy of the student's current class schedule or prior marking period report card must be uploaded as proof of student status and eligibility. The document must clearly show current enrollment in a class as listed above.

WHO DOES NOT QUALIFY for the discount?

Students in Elementary and Middle School, or High School students under 13 do not qualify. Students in trade schools do not qualify.

RULES
